Make a commitment

Sign an MOU with your landlord committing to work together to reduce energy

Establish a working aroup

Bring together representatives of the landlord. facilities manager and all tenants to discuss and implement energy reduction policies and technologies. Consider inviting an expert chair to keep the meetings focused on finding and executing the best ideas. Hold quarterly meetings to discuss actions and results

Communicate

Create a billboard, online forum or similar space for energy education to share the good news and info widely and in a fun and engaging way

Monitor and benchmark performance

Install energy meters with feedback displays and then establish an energy reduction competition between different areas of the building. Engage the security team to track success. Benchmarking energy use in kWh/FTE makes it easy to compare different periods even if occupancy rates change.

energy certificate

Apply for a voluntary energy certificate. The DEC (Display Energy Certificate) rates buildings on an A-G scale, and is already compulsory in public sector buildings over 1000m²

implementing the simple stuff

Measures that have been shown to work well and payback quickly in many commercial offices include installing water-efficient showers to significantly reduce hot water demand and installing 'NightWatchman' software that automatically closes down PCs after working hours

Use revolving doors

Reduce loss of heat or cooled air to the outside from large volume spaces such as entrances, by implementing a policy that requires use of revolving doors (if available or at minimum during off-peak hours). This will also reduce need for heating or cooling at the security desk and improve thermal comfort

Be flexible about lighting, heating and cooling spaces

Use the working group as a forum to agree acceptable temperature ranges and lighting strategies for different spaces such as server rooms, reception, corridors etc.

Collaborate with facilities staff

catering and cleaning teams to review what changes could be made to their activities to reduce unnecessary energy use. For example, reducing the time that lights are left on after a night-time security walk around or shifting cleaning hours to the

jointly in a retrofit

Use working groups to discuss opportunities to share capital costs and energy savings through a more extensive building retrofit. Start with an energy audit to identify the big wins for your building and then discuss options for how costs can be equitably apportioned through service charges.
